Guide to Cite using Bluebook Citation Method (with examples)

Person or entity that supported the publishing or distribution of a work. For example, the publishing company of a book. Suffix: Indicators at the end of a name that tell us more about a person. This includes Jr., Esq., PhD, etc. Title: This is the name of the source. If no name exists, some citations ask for a description. URL
