When preparing for an employment tribunal case, one of the most tedious tasks can be the process of disclosing documents and pulling together the hearing bundle. At first, this may seem

like an administrative task and just a 'box to tick' exercise. However, there is more to document disclosure than meets the eye.

### **Document Disclosure in the Employment Tribunal - How to ...**

In terms of the Tribunal ordering disclosure of documents to the other side, the practice varies between Tribunals, but often there is a requirement for the parties to exchange Lists of Documents. Following exchange of the Lists, each party has the ability to request copies of the documents in the other party's list.

### **Employment Tribunal disclosure - what's in and what's out ...**

The Rules for appeals are governed by the separate Rules of the Employment Appeal Tribunal. A party making a claim has to present (i.e. physically deliver) a valid claim form, on a prescribed form, to an employment tribunal office within the appropriate time limit. A claim form

can be presented electronically (over the Internet or by e-mail).

Employment Tribunal claims can be submitted online, by post or telephone. Time limits need to be observed. You do not have to pay a fee to make a claim to the Employment Tribunal, even if it says so on the form. Once a claim has been made, the other party has to reply in writing within 28 days, setting out their arguments.
